3.	<ul> <li>Business Arising from the November Minutes</li> <li>Ice Fee Reductions discussed per the Town of Black Diamond in agreeance to a reduction in ice fees. The board discussed the possible options and decided on a 15% registration fee reduction for fees paid by participants for the 2022-2023 season. Motion to adopt the 15% refund by Candace Thomson. Seconded by Angie Dawson. All in favour. Motioned carried. The registrar and treasurer will oversee and assist with the refunds.</li> <li>Possibility of instituting a new volunteer position, Manager Coordinator, for the 2023-2024 season was discussed. The position will serve as a liaison to all HCMHA team managers to assist with season startup and provide mentorship throughout the season. All board members are in favour. The new 2-year Manager Coordinator position will be posted for the upcoming season.</li> <li>Annual team jersey fees were discussed. A proposal to incorporate the annual jersey fee into each participant's registration feed was assessed. The unanimous decision by the board to change the annual jersey fee from \$500/team to an undecided amount, to be determined at a later date, was decided and will take effect for the 2023-2024 season.</li> </ul>
